Financial Assistance Fund

Several years ago the Financial Assistance Fund was revamped to encourage participation at the National Conference by financially assisting churches that were unable to send a delegate due to financial restraints. Over the years many of our churches have used this assistance and have been able to send representatives to the Conference where they would otherwise not have been able to attend.

The Financial Assistance Fund has been almost completely depleted. This financial assistance to our churches can be maintained only if all churches support this initiative by following National Council's recommendation of contributing \$50 per delegate. On behalf of those who would not be able to attend without this assistance, thank you.

Payment for Registration and Financial Assistance Fund together can be made online or mailed to the National Fellowship Ministry Centre.

Are you in need of Financial Assistance?

A church can apply for one Travel Assistance Grant and one Financial Assistance Grant if the church meets the criteria.

PLEASE NOTE: The grant cheques will be sent to the qualifying churches after the Conference.

Travel Assistance Grant:

A church that is unable to send a representative due to financial restraints can apply for the Travel Assistance Grant, if the distance to the Conference is in excess of 600 kilometres. The value of the Travel Assistance Grant is \$250.

Financial Assistance Grant:

A church that is unable to send a representative due to financial restraints can apply for the Financial Assistance Grant, if the average attendance at the church's main worship service(s) is less than 150. The value of the Financial Assistance Grant is \$275.

The criteria for qualification are only guidelines. Churches who fall outside the guidelines may still apply, requesting special consideration. A decision will be made regarding these special situations within two weeks of receiving the request, and the result will be sent by email.
